LET CANCELLATION

We refund to you any sum paid to the holiday lets organisation and on the conditions of booking of the let (to the exclusion of administrative or processing expenses and of the insurance premium), when you are obliged to cancel your holiday prior to departure in the following cases:

SERIOUS ILLNESS, SERIOUS ACCIDENT OR DEATH

- of yourself, of your *de jure* or *de facto* spouse, or of the person accompanying you, subject to that person appearing on the same invoice;
- of your ascendants or descendants and/or those of your spouse or partner, or those of the person accompanying you, subject to that person appearing on the same invoice;
- of your brothers, sisters, brothers-in-law, stepbrothers, sisters-in-law, stepsisters, sons-in-law, stepsons, daughters-in-law, and stepdaughters;
- of the person replacing you at work, subject to that person's name being mentioned at subscription to the contract;
- of the person who, during your holiday, is entrusted with:
 - looking after your children who are minors, subject to that person's name being mentioned at the subscription to the contract;
 - looking after a disabled person, subject to that person living under the same roof as you, and to them having you as their legal guardian, and to their name being mentioned as of subscription to the contract.

REDUNDANCY FOR ECONOMIC REASONS of yourself, or of your spouse or partner, the redundancy decision not being known at the time of booking of your let.

SUMMONS TO APPEAR BEFORE A COURT, when you cannot have yourself represented by a counsel.

CONVOCATION TO A RE-SIT EXAMINATION, in higher education only.

DAMAGE TO WORK PREMISES AND/OR TO PRIVATE PREMISES

Occurring after the date of subscription to the present contract due to fire, explosion, or flooding, and subject to the said premises being more than 50% destroyed.

SERIOUS DAMAGE TO YOUR VEHICLE

Arising within the 48 hours preceding your departure, and rendering the vehicle non-repairable in time for you to drive to your place of stay at the initially scheduled date and insofar as your vehicle is essential in order for you to reach that place.

TERROR ATTACK within the 48 hours preceding the start of the let, if the attack takes place within a radius of 100 km.

LACK OF OR TOO MUCH SNOW

- When such a situation occurs:
- in resorts located at altitudes higher than 1,200 m,
 - for any departure from the 3rd Saturday in December to the 2nd Saturday in April
 - when it leads to closure of more than 2/3 of the ski lifts, chair lifts, and other mechanical lifts normally in service on the site of your holiday, for at least 2 consecutive days, within the 5 days preceding your departure.

As regards lets, our cover is granted provided that the let is totally vacated.

OCCUPATIONAL POSTING, OR CHANGE OR REFUSAL OF THE DATES OF PAID LEAVE DUE TO DE THE EMPLOYER

to the exclusion of company heads, self-employed professionals, self-employed tradespeople and show business casuals.

BLOCKAGE OR STRIKE

duly evidenced.

NATURAL DISASTER

as defined by the French Law of 13th July 1982.

POLLUTION

leading to access to the site being prohibited.

HOLIDAY INTERRUPTION COSTS

We reimburse you on a *pro rata* of time basis, up to the amounts indicated in the Table of Amounts of Cover, for the holiday costs already paid for to the holiday lets organisation and not used (exclusive of transport), as from the day after you return early in the following cases:

- following your medical repatriation
- if a close relation is in hospital or dies
- in the event of a serious insurance loss affecting your home.

SPORTING ACTIVITY INTERRUPTION COSTS

We reimburse you on a *pro rata* of time base for the costs of sport or leisure activity passes or packages already paid for and not used (exclusive of transport) when you are obliged to interrupt doing those activities.

The compensation is calculated on the basis of the total price per person of the activities pass or package, up to the ceiling appearing in the Table of the Amounts of Cover.

INDIVIDUAL HOLIDAY ACCIDENT

We cover payment of the compensation provided for in the Table of Amounts of Cover in the event of a bodily accident that you might suffer during the holiday.

BREAKAGE OF SPORTS EQUIPMENT

In the event of breakage of your personal sports equipment (skis, snowboard, windsurfer, surfboard, bikes of all kinds), we reimburse you for the costs of hiring equivalent replacement sports equipment, up to the amount indicated in the Table of the Amounts of Cover (subject to production of documentary evidence).

CIVIL LIABILITY

The financial consequences that you, who do not have personal insurance, might incur following a claim made out or court or through the courts against you by an injured third party due to any bodily injury or material damage caused to others as Booker by accident, fire, explosion, indicated in the Table of Amounts of Cover. Implosion or pollution occurring during your holiday up to the limit of the amounts of cover.

ASSISTANCE TO PERSONS IN THE EVENT OF DISEASE, INJURY, OR DEATH DURING THE HOLIDAY

Dates of effect of covers

Report it immediately to the letting agent and then send the written declaration of loss within 5 business days following the occurrence of the event to: Your real estate agency

Exclusions:

Like any insurance contract, this contract makes provision for exclusions for each of the covers and we would urge you to consult those exclusions attentively.
